

**ORDINANCE NO 2017-102**

**AN ORDINANCE AMENDING ORDINANCE 2011-104  
AN ORDINANCE ESTABLISHING SEWER RATES FOR THE COLLECTION AND  
TREATMENT OF SEWAGE FOR THE CITY OF RIDGETOP SEWER SYSTEM**

**WHEREAS**, the Board of Mayor and Aldermen of the City of Ridgetop finds it necessary to amend Ordinance No. 2011-104 by establishing new rates for residential and commercial collection of sewer collection and treatment within the City of Ridgetop, Tennessee, and further finds it necessary to adopt rates regarding tap fees, Metro capacity fees, initial operating fees, minimum bills for connected and not connected customers, and treatment costs, and further finds it appropriate to categorize rates by residential, small commercial, large commercial (greater than 2,500 gallons per day) and public schools.

**NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF MAYOR AND ALDERMEN OF THE CITY OF RIDGETOP** that the attached rates are hereby adopted as the official rates of the City of Ridgetop for the Ridgetop Waste Water System effective from and after the date of passage.

**Summer Sewer Rates (June, July, August)**

Formula for billing will be to collect September thru May billing drop highest month and lowest month then average the remaining months. This sewer rate service will be available for residential and commercial customers.

\*City to provide detailed list of required products to be used for installation. There will be no exceptions to this list. The city will require a 1500 gallon tank to be used. The city will inspect all hook-ups before sewer use is allowed. Customer is responsible to notify city when ready for inspection.

\*\*treatment cost per 1000 gallons of effluent. This cost subject to change as required.

\*\*\*This fee is per 350 gallons per day of effluent.

\*\*\*\*Must be committed to connecting to a sewer project to be funded by the City at a date set by the Mayor and Board of Aldermen

**Covering of a Sewer Stub Out:**

The Ridgetop Sewer Department shall charge a fee of two hundred and fifty dollars (\$250.00) to the land owner or (contractor, if known) whom covers a Sewer line Stub Out with earth or by any other method to which a locate of the underground sewer line Stub Out is required.
