## TERMS AND CONDITIONS FOR SEWER SERVICES

We/I the undersigned hereafter called the applicants; request the City of Ridgetop, located in parts of Robertson and Davidson Counties, State of Tennessee, hereafter called the city, to provide sewer service to the address shown below, subject to the terms and conditions stated below:

- 1) Shall abide by the City of Ridgetop sewer use ordinance (97-62) and any changes or amendments to said ordinance in the future.
- 2) For services requested the applicant agrees to pay the City of Ridgetop in accordance with the City's rate schedule on file with the City Recorders Office and computed using as a basis the water usage of the applicant as provide by the White House Utility District or any other utility district which may be operating within the jurisdiction of the City. Applicant hereby authorizes the White House Utility District and any other district operating within the City to furnish the city such information concerning the water usage for the applicant so as to make an appropriate rate charge. The amount charged to the applicant is set forth by City Ordinance, which set amount may be raised from time to time as the City so determines after public notice of the City's intention to raise the said rates.
- 3) A statement for services shall be rendered monthly and is due and payable upon receipt and becomes delinquent if not paid by the designated date on bill. The City shall bill the applicant for sewer usage The City shall enforce collection of sewer bill. Late charges and other associated charges including court costs and attorney fees incurred for non-payment of bill shall be due before service is restored.
- 4) The applicant further gives permission to the City, or its authorized representatives the right from time to time to inspect the sewer system, which is located on the applicant's property. Included in this is permission for city authorized personnel to provide service as needed for sewer system, which is located on the applicant's property.
- 5) The applicant understands the City of Ridgetop shall provide all service as is required for system. This will include normal wear/tear on system. Any service problems or damages to system which arise that are deemed by the City to be of malicious intent or due to improper use of the system shall be the financial responsibility to the applicant and service shall cease until remedies are made.
