Police:

The Memorandum of Understanding was signed by both the Sheriff Van Dyke and Mayor Reasoner on January 31, 2020. Alderman Deweese stated since this time Mayor Reasoner has been in touch with and made access to the TBI to secure the evidence on closed legal cases and turn over any narcotics to be destroyed. We have already been in the process of cleaning and making ready the facility for the Sheriff's department and hope to have them occupy the facility in March. Alderman Deweese stated there has been a noticeable increase in law enforcement presence and he believes we have a positive approach for our cities law enforcement peace.
