Commissioners & Department Reports

Utilities:

Alderman Deweese_reported Brian Dean has cleared all the current and previous violations from the Tennessee Public Utility Commission safety inspection evaluation and has completed the cathodic protection survey.

Alderman Deweese reported 58 TN one call tickets were cleared this month.

Alderman Deweese reported the sewer main has been installed on Highland Ave. and a sewer repair was made at city hall after the riser was damaged by thru traffic.

Finance:

Alderman Harrison reported we received a letter from the Tennessee Comptroller of the Treasury recognizing the hard work and commitment in adopting the budget before fiscal year end and filing with their office within 15 days of adoption. Alderman Harrison thanked council for their work on the budget and thanked Kelly Rider for all her hard work.

Park:

Alderman Harrison announced Smoke on the Ridge was a great success.

Alderman Harrison announced the David Wiley Halloween int the Park trick or trunk at Ridgetop Station Park on October 30 from 5 p.m. to 9 p.m.

Streets:

Vice Mayor Shaw stated he had a request to pave Dyer Lane. He reported we will be asking the guys to patch the street until spring.

Vice Mayor Shaw reported he expects to have the final plans for the Shedden Road project by the end of November.

Vice Mayor Shaw reported Browning Estates will bore Lake Road instead of cutting the road to install water for the subdivision.

Fire:

Alderman Rider reported the request to subdivide property on Lake Road was withdrawn by Todd Bollinger, the surveyor.

Business Reports:

City Recorder:

Kelly Rider reported all previously cited violations on the Safety inspection evaluation with Tennessee Public Utility Commission have been cleared.

Kelly Rider reported the city received a certificate from the Tennessee Comptroller of the Treasury recognizing the city adopted the budget on or before the fiscal year end, budget was filed in their office within 15 days of adoption, no issues of concern were raised during their review of the budget and our local government is not currently under the oversight of the Water & Wastewater Financing, or Utility Management Review Board.

Attorney Freeman:

Attorney Freeman reported he sent a letter to Krish Foods on October 8, 2021, concerning noncompliance FOG program. They were originally sent a letter by the city in April 2021 and given 30 days to provide proof of action. He reported the letter states necessary documents to be submitted within 2 weeks of receipt of letter.

Attorney Freeman stated he is awaiting more information to send Dollar General a letter concerning I/I.

Attorney Freeman reported the city has received a franchise agreement from Cumberland Connect. The agreement will be presented in an Ordinance in November meeting.

Mayor Comments:

Mayor Bollinger spoke about Fentanyl being carried through our county and stated he believes Hwy 41 is a main route for smuggling. Mayor Bollinger stated he believes the city needs a police department for that. He stated he is struggling for any way to re-establish a department. He stated he is looking for any way he can raise money to put a department back on the streets patrolling our neighborhoods. If you have any ideas, please bring them to him. He stated he is reluctant to raise taxes but if enough people told him they were willing to do so he would explore that. He stated when he campaigned, it had been inquired if he had considered selling beer and that is why this is on the agenda.
