## **Commissioners & Department Reports**

#### **Utilities:**

Mayor Shaw reported the gas department completed state inspection, repaired gas main on Greer Road, completed Operator Qualifications, completed fifty-eight 811 tickets and 2 service orders.

Mayor Shaw reported the sewer department pumped 5 tanks due to bad pumps and/or high sludge levels, changed 6 pumps, completed fifty-eight 811 tickets and 8 service orders,

Mayor Shaw reported the restrooms at Pioneer Park were demoed, mulch installed at playground at Pioneer Park, grass cut at Pioneer Park, old septic tank demoed at Ridgetop Station Park, dimmer switches installed at city hall, potholes repaired on Lennox Ave and replaced stop sign at Cobb Street.

#### Finance:

Alderman Harrison reported Rebekah Drive paving was completed this month in the amount of \$21,500. The swing sets at Pioneer Park were installed and paid for in the amount of \$13,667, part of this will be reimbursed by insurance.
